The Liberty County Elections Board may adjourn into an Executive Session to receive advice of legal counsel and discuss personnel matters as authorized under Texas Government Code Section 551.071 (consultation with legal counsel) and Section 551.074 (personnel matters). The meeting will reconvene after the Executive Session.

6. ELECTIONS :**a. MARCH 5, 2024, JOINT PRIMARY ELECTION LOCATIONS:**

Consider and approve the proposed voting locations, including recommendations for the combination of certain precincts where necessary. The March 5, 2024, Joint Primary Election will be county-wide voting centers, so voters can vote at any location for early voting and election day voting.

b. MARCH 5, 2024, JOINT PRIMARY ELECTION SUPPLIES:

Consider and approve the purchase of election supplies, including the programming of the election by Hart InterCivic; L & A Testing and Hash testing, including advertisement; ABBM ballot kits; and the purchase of election paper and other necessary supplies.

c. ELECTIONS DIRECTOR NEW HIRE:

Consider the applications of candidates for the position of Liberty County Clerk Elections Director.
