I hereby enter a plea of "no contest" on the above referenced case. I have been informed of my right to a trial; I waive my right to a jury trial or hearing by the Court and discovery under T.C.C.P. Art. 39.14 and request the Court to allow me to complete a Driving Safety Course (DSC) for this case.

I swear or affirm that:

1. I am not in the process of taking a Driving Safety Course or Motorcycle Operator's Training Course and that I have not completed a Driver Safety Course or Motorcycle Operator's Training Course to have a case in any court in the State of Texas dismissed and no such course will appear on my driving record as having been completed within the last 12 months preceding the date of this offense.
2. I have submitted a copy of my non-commercial Texas driver's license.
3. I have submitted a copy of valid proof of vehicle liability insurance, and I am listed as a driver on this policy.
4. I was not cited for driving over 25 mph or in a construction zone with worker's present.
5. I have submitted the **\$146.00 filing fee** which **includes** court costs and a non-refundable \$10.00 administrative fee.

  - In person payments accepted: Money order, Cashier's check, or exact cash.

I understand if I successfully complete the course **within 90 days of the date the affidavit is signed**, my case will be dismissed. If I do not complete the terms of the Driving Safety Course, I will be sent a notice to appear in court to show cause why I did not complete the terms of this deferral. If cause is not sufficient, I understand that the Driving Safety will be revoked, and I will be found guilty of the offense.

I understand that if found guilty, the conviction will be reported to the Department of Public Safety to be placed on my driving record.

I understand that I have 90 days to take the course and submit both the certificate of completion and a copy of my driving record to the court as indicated below:

1. Take an approved driving safety course and submit a copy of the certificate. The certificate must indicate it is for the Justice of the Peace Precinct 5, Liberty County. The copy may be submitted in person or by mail.
2. Obtain a copy of your driving record (version 3A) from the Texas Department of Public Safety. The cost is \$10.00. You may obtain your driving record via mail at: Texas Department of Public Safety, P.O. Box 149246, Austin, Texas 78714-9246 or online at: [www.dps.texas.gov](http://www.dps.texas.gov). It is not necessary to wait for your driving record before attending a class.
