Order Declaring Unopposed Candidates Elected and Canceling Election

At a meeting of the board of directors (the “Board”) of River Ranch Municipal Utility District No. 1 (the “District”) held on April 9, 2026, at which a quorum of said Board was present, as follows:

the following business was transacted:

It was duly moved, seconded and unanimously carried that the order set out below be passed and adopted. The order thus adopted is as follows:

Whereas, it is required by statute that an election of directors of the District be held on the first Saturday in May of 2026;

Whereas, by Order dated February 12, 2026 the Board called an election to elect directors of the District to serve a four-year term;

Whereas, upon receipt of certification under Texas Election Code §2.052 (the “Code”) by the authority responsible for having the official ballot prepared that a candidate is unopposed for an election to an office, the Code requires a political subdivision of the State such as the District to declare each unopposed candidate elected to the office and provides that the election not be held;

Whereas, the District has received the certification from the authority responsible for having the official ballot prepared that all candidates for the office of director of the District are unopposed.

It is, therefore, ordered by the Board as follows:

All unopposed candidates for the office of director are hereby elected to that office, each to serve for four years, and the election is canceled. The president of the Board is authorized to issue a certificate of election to each candidate in the same manner as provided for a candidate elected at the election.

The president or vice president of the Board is authorized and directed to execute and post a copy of this order on election day at each polling place that would have been used in the election as provided by law.

Orden para declarar electos a los candidatos sin oponentes y cancelar la Elección

En una asamblea de la junta directiva (la “Junta”) del River Ranch Municipal Utility District No. 1 (el “Distrito”) celebrada el 9 de abril de 2026, con un quórum de dicha Junta presente de la siguiente manera:

se tramitó el siguiente asunto:

Se presentó debidamente, secundó y aprobó por unanimidad que se aceptara y adoptara la orden descrita más adelante. La orden adoptada de ese modo es la siguiente:

En vista de que el estatuto exige que se celebre una elección de directores del Distrito el primer sábado de mayo de 2026;

En vista de que, mediante la Orden fechada el 12 de febrero de 2026, la Junta ordenó una elección para elegir directores del Distrito que ocupen su cargo durante un término de cuatro años;

En vista de que, tras recibir la certificación bajo la Sección 2.052 del Código Electoral de Texas (el “Código”) de la autoridad responsable de hacer que se prepare la boleta oficial de votación de que un candidato no tiene oponentes para una elección a un cargo, el Código requiere que una subdivisión política del Estado como es el caso del Distrito declare electo a cada candidato sin oponentes al cargo y disponga que la elección no se celebrará;

En vista de que el Distrito ha recibido la certificación de la autoridad responsable de hacer que se prepare la boleta oficial de votación de que todos los candidatos para el cargo de director del Distrito no tienen oponentes.

Por tanto, la Junta ordena lo siguiente:

Por la presente, todos los candidatos sin oponentes para el cargo de director son electos para ese cargo, que cada uno ocupará por cuatro años, y se cancela la elección. Se autoriza al presidente de la Junta a expedir un certificado de elección a cada candidato de la misma manera que se dispone para un candidato electo en la elección.

Se autoriza e instruye al presidente o vicepresidente de la Junta a firmar y colocar una copia de esta orden el día de elección en cada lugar de votación que se hubiera utilizado en la elección, según lo dispuesto por ley.

Aceptada y adoptada en la fecha indicada inicialmente.
