

PUBLIC HEARING ON LIBERTY COUNTY PROPOSED 2025 TAX RATE OF .4800

Statements required in notice if the proposed tax rate exceeds the no-new-revenue tax rate but does not exceed the voter-approval tax rate, as prescribed by Tax Code §26.06(h-2).

NOTICE OF 2nd PUBLIC HEARING ON TAX INCREASE

A tax rate of \$.48000 per \$100 valuation has been proposed by the governing body of **LIBERTY COUNTY, TX**

PROPOSED TAX RATE	<u>\$.4800</u> per \$100
NO-NEW-REVENUE TAX RATE	<u>\$.4622</u> per \$100
VOTER-APPROVAL TAX RATE	<u>\$.4845</u> per \$100

The no-new-revenue tax rate is the tax rate for the 2025 tax year that will raise the same amount of property tax revenue for LIBERTY COUNTY, TEXAS from the same properties in both the 2024 tax year and the 2025 tax year.

The voter-approval rate is the highest tax rate that LIBERTY COUNTY, TEXAS may adopt without holding an election to seek voter approval of the rate.

The proposed tax rate is greater than the no-new-revenue tax rate. This means that LIBERTY COUNTY, TEXAS is proposing to increase property taxes for the 2025 tax year.
