

ORDER DESIGNATING PLACE OF LAW ENFORCEMENT CUSTODY FOR JUVENILES


On this the 9 Day Aug. of, 2022, by the Order of the Juvenile Board, pursuant to Section 52.025 of the Texas Family Code, the following office and places are designated as places where law enforcement officers may have custody for purposes of identification, interrogation and processing of juveniles taken into custody for purposes of identification, interrogation and processing of juveniles taken into custody after complying with Family Code Section 52.02:

1. Juvenile Probation Department Offices in Liberty and Cleveland
2. Deputies Patrol Room at the Liberty County Sheriff's Department in Liberty
3. Office #133 at the Sheriff's Department in the Liberty County Cleveland Annex Building
4. Office #108, #109, #110, #114, #115, #116, #119, #146, #150, at Dayton Police Department
5. The Corporal's office and the Squad Room at the Cleveland Police Department
6. The offices and facilities of the Magistrates of Liberty County, TX as defined in Article 2.09, Texas Code of Criminal Procedure.
7. Office of the Texas Rangers in the Liberty County Courthouse
8. Office #1114 at Dayton High School, Office #504 at Woodrow Wilson Junior High School
9. The office of Captain of Criminal Investigations at Liberty County Sheriff's Department in Liberty, TX
10. The Sheriff's Department Interview room in Liberty, TX
11. The Liberty County Sheriff's Investigator's office in Liberty, TX
12. The interrogation room and Juvenile Processing Room at Liberty Police Department
13. The Juvenile Processing Office 123B at C.I.S.D. Service Center located at 326 FM 1010 Cleveland, TX


It is further ordered that the custody of any child in the above-mentioned places and facilities for purposes of identification, interrogation and processing shall not exceed a period of six (6) hours, and the child will not be permitted contact with adult prisoners or any other adult offenders. If a jail or lock-up is used as part other this 6-hour custody, there must be a sight and sound separation of juveniles from adult prisoners.

A child may not be left unattended in a juvenile processing office and is entitled to be accompanied by the child's parent, guardian, custodian, or by the child's attorney. A parent, guardian or custodian must be notified as soon as possible after the child is taken into custody.




