DCM Services:

- The Disaster Case Management Program (DCMP) is time limited and provides free personalized assistance to individuals and families recovering from Hurricane Beryl.
- ➤ A trained Disaster Case Manager (DCM) will assess disaster related unmet needs and connect the survivor with community resources.
- DCMs specialize in assisting survivors with individualized disaster recovery plans, FEMA Appeals, and resource applications for programs such as the Texas General Land Office Hurricane Beryl Disaster Reimbursement Program and Homeowner Assistance Program.

DCM Roles & Responsibilities

- Outreach to survivors throughout the 22 impacted counties.
- Intakes and Assessments for survivors that wish to join the DCMP.
- Serve as primary point of contact for the survivor.
- Develops a Long-Term Recovery Plan with the client.
- Partners with Long Term Recovery Groups to access resources.
- Works with DSC SVDP's Resource Coordinator to refer the client to viable resources for recovery.
- Refer homeowners requesting repair or rebuild assistance to DSC SVDP's Construction Cost Analyst to complete a home visit to assess Hurricane Beryl related damages.





DCMP and LTRG Engagement


- A Long-Term Recovery Group (LTRG) is a collaborative network of individuals, businesses, faith-based and nonprofit organizations, philanthropic funders, and other recovery partners who work together to provide the funding, volunteers and materials needed to address unmet disaster survivor needs.
- DSC SVDP-USA and Hope Disaster Recovery are actively reaching out to (LTRGs) throughout the 22 counties to discuss resources and capacity building.
- The LTRG is a vital part of a survivor's recovery and is often the last stop in the Sequence of Delivery when all other resources are exhausted.
- The DCMP partners with LTRGs to inform survivors about the time-limited Disaster Case Management Program and encourage participation.

DSC SVDP's goal is to identify eligible survivors with remaining Hurricane Beryl disaster-related unmet needs in the 22 assigned counties. DSC places a special focus on vulnerable populations and communities.

- Disaster Services Corporation (DSC) is a Catholic lay organization, a subsidiary corporation of St. Vincent de Paul USA, having become a 501 (c)(3) non-profit in 2017
- One of the earliest charities in the United States to assist with disaster relief
- Founding member of National VOAD
- Divided into nine regions in the United States
- Regional leadership coordinates with SVDP Councils
- US branch covers the United States and American Territories
- International branch out of Paris, France
- Maintain permanent offices in Irving, TX and Washington, D.C. with contract program offices across the nation.

- Supports Disaster Recovery Centers known as Parish Recovery Assistance Centers (P-RACs)
- Represents DSC at local Multi Agency Resource Centers (MARC)

- House in a Box[™] provides families who have lost everything with brand-new furniture and household essentials, restoring dignity and stability after disaster strikes.
