Procedure To Secure A Private Road Number

The Liberty County Central Appraisal District should be contacted with a request for a private road number. Contact information is as follows:

The Liberty County CAD will provide the applicant with a private road application form, appropriate maps showing location of proposed private road and contact information for Liberty County precincts.

The applicant should fill out the CAD form and submit it and the associated map to the Liberty County Permitting Department as shown below.

The Permitting Department will review the application for completeness. If complete, the document will be approved, and the package will be returned to the Central Appraisal District with a copy being maintained on file at the Permitting Department. A copy will also be provided to the Precinct where the private road is located.

Private road numbers will be assigned on the basis of the nearest established county road. Two additional digits will be added to the number. As an example, a private road number is requested in a location that has close proximity to CR 133. In this case the assigned private road number would be PR 13301. It is anticipated that this method of road assignment will work better for first responders.

The County Permitting Department will maintain a file on all private road numbers that are issued and will be responsible for road number assignments.

It has been confirmed with the County Attorney's office that requests to the precincts for private road number signage should be on a fee basis. Each precinct should develop its cost for such signage and assess this amount to persons requesting private road signage.
