(3) Residential building permits, commercial building permits, commercial occupancy permits, mobile home permits, residential septic permits, commercial septic permits, meter pole permits, cell tower permits, junk/scrap yard permits, fireworks stand permits, culvert sizing, driveway/culvert permits, pipeline permits and associated road use agreements, recreational vehicle park permits, mobile home park permits, logging permits, commercial fuel tank permits, oil well permits and associated road use agreements, re-inspection of septic installations that fail their final inspection, field inspection of septic systems with possible citation for having a non-functional system, field inspection and possible citation associated with failure of septic site evaluators and installer to comply with TCEQ regulations, commercial sewage inspections of smaller package plant systems that are permitted by Liberty County.

Fees associated with various Liberty County permits are shown on the attached sheet. In conjunction with payments associated with fees, the department accepts Visa, Master Card, Debit Cards and Corporate Checks. Cash is not accepted.
